

2020 Call for Nominations for Election to the Board of Directors

The Canadian Foundation for Dietetic Research (CFDR) Board of Directors is seeking nominations for the election of new Directors to be held at our Annual General Meeting, November 2020. CFDR is a registered charitable foundation that provides grants for practice-based research in dietetics and nutrition. Created by Dietitians of Canada in 1991, CFDR celebrates its 29th year in 2020. The Board oversees the direction and accountability of the foundation. The deadline for nomination submissions is **June 15, 2020**.

CFDR is seeking new nominations of qualified and interested individuals who are committed to CFDR's mission and purpose. We are looking for candidates with experience in one or more of the following areas:

- fundraising,
- finance,
- scientific research communication,
- leadership.

The mission of CFDR is to cultivate and fund practice-based dietetic research.

This is an important time for the CFDR Board. Directors will have an opportunity to:

- set the strategic direction of CFDR in a time of change for our fundraising model,
- participate in CFDR's governance,
- network with like-minded supporters of practice-based research,
- contribute to working groups involved in communications, research and fundraising.

The length of the term is 2 years and directors are encouraged to renew for a second term. The time commitment for Directors may vary but will generally include:

- Orientation to the Board: two 60-90 minute conference call meetings.
- Meetings: 8 regular board meetings per year (90-minutes each). One, full-day, in-person meeting (November in Toronto). Board meetings require some preparation including pre-reading and discussion using online platform.
- Participation on Board committees and representation of CFDR at meetings with various constituents.
